Having read this waiver and knowing these facts, and in consideration of accepting of this training program, I, for myself, and anyone entitled to act on my behalf, waive and release Liz Lindsay and Janes on the Run and any and all of its founders/owners, directors, officers, employees, volunteers, sponsors, and agents working for said entity from all claims and liabilities of any kind, arising out of, or related to my participation in this training program, even though that liability may arise out of negligence or carelessness on the part of the persons named in the waiver.
